PERIOD OF PERFORMANCE FOR ASSIGNMENT REHAB 215 AND ASSIGNMENT REHAB 225:

Each Work Order shall have an initial term of 45 Calendar Days after Notice to Proceed for Rehabilitation.

All projects awarded under this contract **shall be required** to schedule and pass a preconstruction walkthrough within **25 calendar days** of contract execution. All projects awarded under this contract **shall have** all NTP's issued within **60 calendar days** of contract execution (unless requested earlier by GCs). NCORR reserves the right to issue projects Notice to Proceed at any point as determined in the best interest of the program and its applicants.

PERIOD OF PERFORMANCE FOR RFB.INFORMAL.DEMO 03

Each Work Order shall have an initial term of 20 Calendar Days after Notice to Proceed for Demolition.

If applicable, Environmental remediation shall have an initial term of 10 Calendar Days after issuance of Notice to Proceed.

All projects awarded under this contract **shall be required** to schedule and pass a preconstruction walkthrough within **25 calendar days** of contract execution. All projects awarded under this contract **shall have** all NTP's issued within **45 calendar days** of contract execution (unless requested earlier by GCs).

At the end of the Work Order's current term, the State shall have the option, in its sole discretion, to extend the Work Order on the same terms and conditions. The State will give the Vendor written notice of its intent whether to exercise each option no later than 10 days before the end of the Work Order's then-current term.

AMENDMENT EXECUTION AND RETURN:

To prevent delay in project completion, Vendor must execute/sign and return any amendment within **7 calendar days** after issuance. Failure to do so may result in revocation or termination of the contract, in whole or in part, at the sole discretion of the State.
