AMENDMENT NUMBER ONE (1)

State of North Carolina Department of Public Safety NC Office of Recovery and Resiliency (NCORR)

This document shall amend Contract Assignment Rehab 181 for Rehabilitation Projects ("Agreement") by and between Lightning Labor Construction Services, LLC, (the "Vendor") and the State of North Carolina, Department of Public Safety, Office of Recovery and Resiliency (hereinafter referred to individually as "State" or "NCORR") executed on November 14, 2023. Except as expressly provided in this Amendment, all terms and conditions of the original Agreement shall remain in force and shall apply to this Amendment.
