AMENDMENT NUMBER ONE (1)

State of North Carolina Department of Public Safety NC Office of Recovery and Resiliency (NCORR)

This document shall amend Contract **RFB.Informal.Abatement 08** for **Residential Asbestos Abatement Services** ("Agreement") by and between Tracco, LLC (the "Vendor") and the State of North Carolina, Department of Public Safety, Office of Recovery and Resiliency (hereinafter referred to individually as "State" or "NCORR") executed on June 29, 2022.
