This document shall amend Contract **RFB.Informal.Abatement 13** for **Residential Asbestos Abatement Services** (“Agreement”) by and between Vistabution, LLC (the “Vendor”) and the State of North Carolina, Department of Public Safety, Office of Recovery and Resiliency (hereinafter referred to individually as “State” or “NCORR”) executed on August 15, 2023. Except as expressly provided in this Amendment, all terms and conditions of the original Agreement shall remain in force and shall apply to this Amendment.
