Narratives

Disaster Damage:

On September 14, 2018 Hurricane Florence made landfall near Wrightsville Beach in New Hanover County, North Carolina. In the days prior to landfall, Florence had exhibited wind speeds typical of a Category 4 Hurricane but was downgraded to Category 1 before eventual landfall

Despite the downgrade in intensity, Florence inundated parts of North Carolina and was the wettest tropical cyclone in the history of the Carolinas with rainfall totals greater than 25 - 35 inches in parts of the State. The rainfall intensity, combined with the slow-moving southwest track of the system and large wind field contributed to historic flooding across Southeastern and Central North Carolina. The rainfall fed the Cape Fear, Lumberton, and Waccamaw Rivers and lead to intense riverine flooding, damaging infrastructure, homes, and businesses in the surrounding area. More than nine river gauges registered flood conditions greater than a 500year event. The majority of damage caused by Hurricane Florence is due to this extended rainfall as the storm trekked southwest slowly through coastal North Carolina for six days.

In addition to rainfall, Florence drove a record-breaking storm surge of 9 – 13 feet. The result of the storm surge, rainfall, and river overflow was catastrophic and life-threatening floods for a massive geographical extent of the State.

Recovery Needs:

The State of North Carolina consulted multiple resources to better understand the unmet recovery needs relative to housing, infrastructure, and economic revitalization following the catastrophic impacts of Hurricane Florence. The following analysis identifies the effects, longterm recovery needs, and recovery priorities relative to the CDBG-DR allocation provided to the State to perform disaster recovery activities. The unmet recovery needs analysis considers the impacts of DR – 4393, the presidentially-declared disaster designation for Hurricane Florence. Where feasible, recovery programs are taken in context with the ongoing recovery needs relative to the impacts of Hurricane Matthew to find efficiencies in planning, program design, and eventual program implementation.

The foundation of the analysis of the unmet recovery need concerning housing is the State of North Carolina Housing Impact Assessment, completed by the Federal Housing Recovery Support Team (RSF) in coordination with HUD on March 12, 2019. The results of the Housing Impact Assessment were compared to the requirements set forth in 85 FR 4681 and previous Federal Register Notices. Where necessary, the Housing Impact Assessment assumptions were built upon or modified to better meet HUD guidance on the unmet housing recovery need methodology set therein.

Other data sources were necessary to complete the analysis of unmet infrastructure recovery needs and the analysis of economic impacts from the storm. The analysis is based on data provided by state and federal agencies, impacted areas, local nonprofits and other stakeholders, the U.S. Census Bureau, the U.S. Small Business Administration (SBA), The Federal Emergency Management Agency (FEMA), and other sources. The North Carolina State Office of Budget and Management (NCOSBM) drafted multiple reports in October 2018 that cataloged initial impacts and provided an estimate of the unmet recovery needs at that time. This groundwork was necessary to develop the current unmet recovery needs analysis. The full NCOSBM report is available at https://files.nc.gov/ncosbm/documents/files/Florence_Report_Full_rev20181016v10.pdf. The analysis includes details specific to the HUD-identified most impacted and distressed (MID) areas as well as other impacted areas. The analysis provides the foundation for delivering recovery programming that seeks to cure the effects of the disaster while also preparing North Carolina for future disaster events.

NCORR is charged with administering CDBG-DR funds as Grantee to HUD. Therefore, NCORR has sought to develop an unmet needs analysis which is true to the conditions in the State using the best available data and resources to help inform the disaster recovery. NCORR understands that future information may become available that would adjust the findings of the unmet needs analysis. Changes to the Action Plan may result if additional funds become available or if new information is discovered during program planning, development, and delivery that informs a more beneficial recovery.

Overall Progress Narrative:

In this quarter, The NC Office of Recovery and Resiliency (NCORR) made several personnel, policy, and procedural changes to expedite and improve the delivery of its programs. In addition to such changes, NCORR undertook an update of its Action Plan during this quarter to update the analysis of the unmet need and align recovery efforts across all funding grants. During this quarter, the work of UNC's Development Finance Initiative (DFI) continued as the group completes Phase I of their project, which includes Housing Gap Analyses, Opportunity Site Identifications, Community Partner Identifications,



Financial Feasibility Analyses, and provides potential implementation strategies for identified MID counties. Phase II of the project will continue in future quarters as DFI provides site-specific Feasibility Analyses, Development Partner Selection, and potential RFP Development for the MID counties. During Q4 2022 the Bladen County Storm Water Drainage study progressed to 60% completion.

HRP has completed the construction of 56 for low- and moderate-income beneficiaries, 2 urgent need beneficiaries, of which 1 elevated home is included construction complete. Of the total completed construction activities, there are 9 beneficiaries for Robeson County as well as 31 Rehabilitations that were completed thus far.

Five Florence projects as part of the Affordable Housing Development Fund had change in activity during the quarter. Cliffmore Park, East Haven Apts, Northeast Pointe II, Palatine Meadows, and Starway Village all received HUD AUGF. In addition, NCORR issued the Project Specific Award Letters for the Arlington Trace and Starway Village projects. The Code Enforcement Support program continues to support NCORR with building inspections to ensure quality build products as well as assist in identifying jurisdictional permitting issues that may slow progress. The team completed over 200 building, mechanical, electrical, plumbing, and fire inspections on NCORR projects across seven jurisdictions as well as continuing to coordinate with Craven, Pender, and Edgecombe counties to complete cooperative agreements allowing the Department of Insurance to perform inspections.

The Department of Insurance team continues to develop online level I code enforcement training materials for jurisdictional inspectors to further inspection capacities or perform continuing education for professional development. Once all five (building, mechanical, plumbing, electrical, and fire) level one certification modules are complete, the team will begin designing level II certification products.

Following the completion of Round 2 of the Public Housing Restoration Fund in last quarter, the 5 awarded Public Housing activities underwent preliminary draft of Subrecipient Agreements. The Fayetteville Metropolitan Housing Authority and Wilmington Housing Authority Subrecipient Agreements were completed and executed during this quarter. Subrecipient North Carolina Housing Coalition began marketing and intake of applications for the Homeownership Assistance Program (HAP) during this quarter. A first purchase closing was originally scheduled for this quarter but was delayed until Q1 2023.

In conjunction with the Homeownership Assistance Program (HAP), the North Carolina Housing Coalition has begun its purchase assistance/housing counseling activities to applicants/potential homebuyers

The NCORR Compliance Team has provided in-person and remote technical assistance for internal and external recipients. Remote monitoring for two subrecipients was completed within this Q4 timeframe with no findings or concerns. Compliance assisted in Personally Identifiable information training for NCORR. Additional documentation for all technical assistance and monitoring was previously provided via individual monthly reports.

Technical assistance on cross-cutting regulations was provided on the following topic: Uniform Relocation Act. NCORR and sub-recipients attended a two-day training delivered by a compliance specialist on Uniform Relocation Act. On October 20, 2022, compliance attended an on-site visit to multiple sites funded by CDBG-DR funds. The on-site visit allowed technical assistance opportunities and visualization of project statuses. Five projects and three sub-recipients benefited from this onsite technical assistance on how to prepare for monitoring and audits. This allowed subrecipients to learn how to become more efficient, organized, and ready for future monitoring or audits.
