### **AMENDMENT NUMBER ONE (1)**

# State of North Carolina Department of Public Safety NC Office of Recovery and Resiliency (NCORR)

This document shall amend Contract #19-RFP-464735590-DAD for NCORR Staff Augmentation: Community Development Block Grant-Disaster Recovery/Community Development Block-Grant Mitigation Expert Administrative Support ("Agreement") by and between Hunt, Guillot & Associates, LLC (the "Vendor") and the State of North Carolina, Department of Public Safety, Office of Recovery and Resiliency (hereinafter referred to individually as "State" or "NCORR") executed on September 29, 2022. Except as expressly provided in this Amendment, all terms and conditions of the original Agreement shall remain in force and shall apply to this Amendment. This Amendment, including all previous Agreements, Requests for Proposal, Responses, BAFOs and all of its exhibits constitutes the entire agreement between the parties. The Agreement is hereby amended as follows, to become effective upon signature of all parties.

This Amendment includes a change in Task 6 with the addition of a unit cost basis for Tier II environmental review records. Unit costs have different prices depending on the time the unit is delivered. This Amendment increases the current year one cost of Task 6 from \$850,000 to \$3,810,000 for an increase of \$2,960,000. The contract year one not-to-exceed amount is increased from \$18,019,000 to \$20,979,000. The three year not-to-exceed amount is increased from \$54,057,000 to \$56,757,000. Given the scope adjustment requires continued service into 2024, the first contract renewal of 6 months is also executed, extending the contract term to March 29, 2024. The first 6-month contract renewal includes costs commiserate with a six-month renewal. The following Pricing Table shall amend the Pricing Table from the current agreement:

NCORR may add additional units to the renewal if additional units are identified when or if the renewal is requested.

The entirety of the scope increase is the addition of the unit cost and expected units delivered for complete Tier II environmental review records for activities where NCORR has elected to perform a tiered review (Homeowner Recovery Program and Strategic Buyout Program) as of the date of this amendment. Hourly billing for those activities is no longer permissible and the unit cost will be used instead. Hourly Billing may still be used for other Task 6 work and thus the hourly units have been reduced for the first and subsequent 6-month renewals.

Task 6 within Section 5.2 Tasks/Deliverables shall be replaced with:

"Three (3) **CDBG-DR Environmental Review Specialists** — Services provided by the CDBG-DR Environmental Review Specialist may include but are not limited to:

- a. Documenting program compliance with federal environmental regulations including NEPA.
- b. Providing expertise to inform NCORR and NCORR's SOR developers with building or modifying workflow modules in the SOR. Skills sought include policy and programmatic expertise to inform NCORR and NCORR's developers of best practices and do not include SOR development skills.
- c. Reviewing area-wide (Tier 1) environmental review records prepared by NCORR's contractors for compliance and accuracy.
- d. Reviewing site-specific environmental reviews prepared by NCORR's contractors for compliance and accuracy.
- e. Providing environmental Subject Matter Expertise in all of North Carolina's Action Plan-defined programs including but not limited to housing programs, buyouts and acquisitions, and infrastructure repair.
- f. Providing training to state, contract, or local staff.
- g. Assisting with other programs, if needed.

The Environmental Review Specialist should have a minimum of three years direct experience in providing environmental review Subject Matter Expertise for a grantee or subrecipient of equivalent or greater scope of service and size to North Carolina. Consultant should have prior experience authoring or reviewing area-wide (Tier 1) environmental review records and authoring or reviewing site-specific (Tier 2) environmental reviews.

#### Deliverables:

NCORR defines a "Tier II Environmental Review Record Complete" as a record that is prepared for NCORR review and acceptance (Ready for QC). This is not to be construed as deferring NCORR's responsibility to act as the Responsible Entity, which NCORR remains responsible for. If the complete record is provided and does not require revision but is reviewed by NCORR after the timelines expressed above, it will be paid at the rate applicable when the complete record was submitted for review. For example, if a record is complete for NCORR review on Friday, March 29, 2024 but is not reviewed and accepted by NCORR until April 1, 2024, that unit shall be paid at the \$590/unit rate (See Cost Table). Any incidental cost to preparing the Tier II record shall be accounted for in the billing rate for the unit, including internal and external coordination, any necessary consultations, and other tasks."

NCORR and the Vendor shall agree on a workplan within two weeks of execution of this amendment and will establish a weekly recurring meeting to identify obstacles to timely completion and progress on the updated Task 6 activity until this activity is considered complete.

The undersigned individuals below represent and acknowledge they have the company power and authority to bind Hunt, Guillot & Associates, LLC and the State of North Carolina Department of Public Safety to the terms of this Amendment.
