AMENDMENT NUMBER ONE (1)

State of North Carolina Department of Public Safety NC Office of Recovery and Resiliency (NCORR)

This document shall amend Contract RFB.Informal.Rehab 09 for Residential Home Rehabilitation ("Agreement") by and between Lightning Labor Construction Services, LLC (the "Vendor") and the State of North Carolina, Department of Public Safety, Office of Recovery and Resiliency (hereinafter referred to individually as "State" or "NCORR") executed on September 28, 2023. Except as expressly provided in this Amendment, all terms and conditions of the original Agreement shall remain in force and shall apply to this Amendment. This Amendment, Request for Bid, Responses, and all of its exhibits constitutes the entire agreement between the parties. The Agreement is hereby amended as follows, to become effective upon signature of all parties.

This Amendment removes projects APP-08241 (518 School Road) and APP-03456 (121 Smith Avenue) and replaces them with APP-07320 (5312 Cherry Lane) and APP-09712 (113 King George Court).
