# **AMENDMENT NUMBER ONE (1)**

# State of North Carolina Department of Public Safety NC Office of Recovery and Resiliency (NCORR)

NCORR reserves the right to issue projects Notice to Proceed at any point as determined in the best interest of the program and its applicants.
