This document shall amend Contract **Assignment Recon 35 for Reconstruction** ("Agreement") by and between Steve Stone Developments, (the "Vendor") and the State of North Carolina, through the Department of Public Safety's, Office of Recovery and Resiliency (hereinafter referred to individually as "State" or "NCORR"), executed on December 08, 2025. Except as expressly provided in this Amendment, all terms and conditions of the original Agreement shall remain in force and shall apply to this Amendment. NCORR reserves the right to issue projects Notice to Proceed at any point as determined in the best interest of the program and the subject applicant(s).

AMENDMENT EXECUTION AND RETURN:

To prevent delay in project completion, Vendor must execute/sign and return any amendment within **7 calendar days** after issuance. Failure to do so may result in revocation or termination of the contract, in whole or in part, at the sole discretion of the State.
