Except as provided in this Amendment, all terms and condition of the original Agreement shall remain in force and shall apply to this Amendment. This Amendment, including all previous Amendments, Agreement, Request for Proposal, Response, BAFOs and all of its exhibits constitutes the entire agreement between the parties.

The Parties wish to amend the current contract as follows:

- 1) Within "Errata and Exceptions" which starts on page 61:
 - a) Under the sub heading "General Project Exceptions:
 - i) Delete the first paragraph and replace with: Publicis Sapient Salesforce Practice's estimates and the statement of work herein are based on the following list of key assumptions. Deviations that arise during the project will be managed through the Change Control Procedure, and may result in adjustments to the Project Scope, Estimated Schedule, Charges, and other terms. These adjustments may consist of charges on a time and materials basis using the negotiated rates in effect at such time for any resulting additional work or waiting time.
 - ii) Regarding Paragraph 3. Note that Vendor shall provide the State with archived records following the end of the contract.
 - iii) In Paragraph 8. Replace DORA with NCORR. Replace Paragraph 9 with: The State is most knowledgeable about how the new application will meet their business process requirements, and is therefore responsible for conducting User Acceptance Testing (UAT) within the project timeline. PS SP will conduct Unit, System, and Integration testing on our delivered functionality, but the State will be highly engaged, but onsite PM should take lead on scripting, setting up testing environment and accounts, arranging logistics, etc. for all User Acceptance Testing.

The acceptance process should be based on agreed upon criteria, during an agreed upon time period (3-5 days is usually sufficient). PS SP will correct defects at no extra cost (or issue a refund if unable to do so). Replace Paragraph 16 with: PS SP shall develop custom pages to be supported by Salesforce-approved browsers. Strike Paragraph 17 and 20.
- b) <u>Under Contract Assumptions</u>:
 - i) Strike Paragraphs 3 and 9.
- c) Exceptions to Terms and Conditions:
 - i) Strike entire section
- 2) SFDC Service Terms which starts after page 66:
 - a) Strike the entire section.
