Welcome, Introductions, and Overview of Agenda

T. Vinson and M. Byrne provided a brief introduction and agenda overview. Meeting to focus on first of three topics for forming recommendations.

Presentation Regarding the NC Natural and Working Lands Stakeholder Group

R. Savage, president and founder of Carolina Wetlands Association, discussed the draft recommendations of the North Carolina Natural and Working Lands Stakeholder Group regarding climate adaptation and resiliency. The report will be provided as an appendix to the NC Climate Risk and Resiliency Plan.

Issues raised in discussion:

- Disconnect between modeling being done and benefits of nature-based solutions. How do we make that connection? How do we take advantage of existing modeling and build on it?
- NRCS Emergency Watershed Protection Program: potential for agriculture to be a big help in this—wetlands/floodplains restoration; restoring stream and wetlands functionalities; cover crops and other efforts to restore water
- holding capacity on agricultural lands.

Develop Recommendations for Increasing Implementation and Effectiveness of Nature-Based Infrastructure and Restoration

- RSF began discussion of recommendations to be provided to NCORR, NCEM and the Governor's Office, facilitated by T. Vinson and M. Byrne. This is the first of three topics proposed by the RSF at prior meetings. Three topics include: Increasing Implementation and Effectiveness of Nature-Based Infrastructure and Restoration; Capacity Building; and Data and Modeling Needs.
- Timeframe for recommendations: Need recommendations for short-term and long-term. For more formal recommendations, probably looking at longer term. But on an informal basis, state staff is already incorporating ideas that have come up in RSF discussions.
- Format for recommendations: Up to this group. Could be a formal letter and document formalizing recommendations.
- Type of recommendations: Specific recommendations are ideal. Not just policy, but also data needs, legislative proposals, procedural changes. Can build off the more general recommendations in the forthcoming Natural and Working Lands Stakeholder Group's recommendations and the NC Risk and Resilience Plan.
- Even if recommendations are broader than scope of NCEM/NCORR/Governor's Office, should still make them. Because this group combines both state staff and advocacy groups, it is a powerful tool for getting good ideas out and generating broader support.
- Next Steps:
 - Members to submit recommendations to M. Byrne prior to the next meeting on March 26, 2020, for discussion at that meeting.
 - Please provide recommendations for all three topics.
 - M. Byrne to share the housing recommendations with this group so that they can determine overlaps.
 - J. Kjelgaard of NRCS offered to present on their disaster recovery programs at one of the next meetings.
 - T. Vinson to email group a copy of the State Disaster Recovery Task Framework.

Requests from Communications and Intergovernmental Relations RSF

The Communications and Intergovernmental Relations RSF has asked if the other RSFs would provide feedback on the areas that they they've noticed a need for improved communication.

- Lack of guidance after Hurricane Florence for when it was safe to get back into the water for swimming which led to people swimming before it was safe.
- Need more messaging about chemically treated wood that was handled as driftwood so was burned by homeowners which resulted in the release of chemicals into the atmosphere
 - The fact that many people don't realize that boats need to be removed during a disaster just like houses are prepared to prevent damage to streams and rivers
